

## 2016 Wailea Open Tennis Championships

## Rules

- Entries with complete fees must be received by 5 p.m., May 21. Mailing address: Wailea Tennis Club, 131 Wailea Ike Place, Wailea, HI, 96753. Attn: Patrik Ekstrand. Entry fees must be paid with cash or check only; credit cards accepted only for online registration.
- 2. Draw: Call Wednesday, May 25, after 3 p.m. for your times or check online.
- 3. USTA Rules will govern the tournament. The USTA code of conduct will be in effect. USTA number required: applications without USTA number will not be accepted.
- 4. All matches will be best of three sets. All matches through the quarter finals will be two full sets with a 10 point match tie break in lieu of the third set. The Semi finals and finals will be the best of three full sets. The 12-point tie-break will be played at 6 games all.
- 5. Players must report 15 minutes prior to start of match. Warm-up limited to 5 minutes. Be prepared to play as many matches as necessary each day. Matches may be played on Friday, May 27, from 4 p.m., depending on draw size. If you have other priorities which might conflict with scheduled matches, please do not enter.
- 6. Proper tennis attire is required. No tank tops.
- 7. Some matches may be played at alternate sites. Some matches may be played under lights at night.
- 8. Tournament Director reserves the right to make necessary changes to draws/divisions.

## **Entry Fees**

Entry Fees may be submitted online at waileatennis.com or by check or cash. Please make checks payable to Wailea Tennis Club. Entry fee for cash or check is \$67.71. Entry fee includes one or two events (1 singles/1 doubles or 1 doubles/1 mixed doubles), shirt, and player's party Saturday night at 5 p.m. Late applications will be accepted at a higher entry fee on May 22<sup>nd</sup> only. Fees for late entries are \$80/person and must be paid in person only.
